- d) Earnest Money : Rs. 4010.00 only in form of DCR/NSC/Bank Draft of any Nationalised Bank in favour of Chairperson, Cooch Behar Municipality payable at Cooch Behar. Balance Earnest Money @ 2 (two) % of the tendered amount will have to be deposited at the time of agreement.

Application (in duplicate) along with the proof of their current Credentials of satisfactory completion of similar nature and valid certificate of upto-date clearance of I.T., P.T. & PAN Card, GSTIN (each documents should be in original & 1-set of XEROX) will have to be submitted to the office of the Chairperson, Cooch Behar Municipality and failing which no permission for purchasing tender paper will be accorded. **Submission of original certificates is must.** Intending tenderer may apply and obtain tender papers will in advance to guard against any difficulties due to possible absence from the headquarters of the Chairperson and concerned schedule of rates and site condition well in advance. **No authorised persons will allowed to apply, purchase and to drop the tender forms.** Percentage rate (At par/Less/Above) than the estimate put to tender should be quoted both in figure as well as in words. All corrections in the tender should have initials with date. Any tender paper which does not fulfill any of the above condition or becomes incomplete in any respect shall liable to be rejected.

The Contractor must obtain the License under the Contract of Labour (Regulation & Abolition Act. 1970) and produce as and when necessary. This may strictly be followed otherwise it will mean violation of contract.

In addition to all usual deductions of labour CESS @ 1 % of gross bill value will be made against the work.
